Because engineering research can transform the world

Pull Barriers

- Officials don't have access to or culture of reading peer reviewed journals.
- Few civil servants with STEM background.
- Pressure for policy solutions now.
- Don't know landscape.
- Technology moving very fast
- Policy cycle complex rarely going looking for one simple answer.
- Too much to do / to little time.

Push Barriers

- Academics don't speak officials' language
- Naïve or unrealistic expectations
- Think telling us once is enough
- Failure to understand wider political / societal / economic pressures
- Publish or perish especially for early career researchers
- Policy engagement is a skill that's not always developed
- Research talent orthogonal to policy influencing talent
- Too much to do / to little time.

Identify

Who needs to know about it?

- Civil servants Grade 7s to DGs
- Relevant ministers
- Select Committees / APPGs
- Think tanks and journalists

What are the ways in?

- Relevant mega-policies, e.g. Industrial Strategy, Northern Powerhouse?
- Public concern?
 - Existing burning platforms?

Engage

Establishing the initial connections and awareness

- Get a meeting with officials / minister / MPs
- Run a parliamentary briefing event
- Invite an official to come and speak at a conference
- Effective media:
 - Press releases
 - Interviews
 - Social media
 - Respond to government consultations
 - Have a blog and comment on both research and relevant topical news

Make yourself an integral part of the landscape

- Build strong personal relationships with officials at all levels
- Comment on government announcements in your area (and ensure the press is aware).
- Regular series of engagement to which officials, ministers, parliamentarians and think tanks are invited (e.g. HEPI parliamentary breakfast briefings).
- Provide the secretariat for a relevant APPG.
- Offer to lend a PhD student / post-doc to the department at a high resource time (e.g. consultation).
 - Bid to carry out government-commissioned policy research.

Impact

Understand what you're looking to achieve

- Greater awareness?
- A change in public attitudes?
- Better targeted policies?
- New laws / regulations?
- A change to existing regulations?
- Targeted investment or research programmes?

'Centre' Approach

Advantages of a Centre Approach

- Clear and identifiable brand
- Can maintain long-term relationships
- Allows division of labour research, influence and impact
- Skilled non-academic staff can support researchers to have impact
- Provides management framework in which impact work can be valued

Examples of existing effective centres

- Centre for Competition Policy (UEA)
- UK Trade Policy Observatory (Sussex)
- National Graphene Institute (Manchester)
